# Politicians or Puppets

FRITZ MONDALE

## Militarism

"I sat for four years on the National Security Council. I saw all the papers, worked with all our defense and intelligence agencies and took part in every military decision."

-- Walter Mondale in speech to Newspaper Publishers Association, NY Times

When Jimmy Carter was in office he directly involved Fritz Mondale in the major foreign policy decisions. Mondale lobbied for and supported Carter's militarist programs including major nuclear weapons development and military aid to El Salvador.

- \* reintroduced military draft registration
- \* initiated the MX missile
- \* promoted the idea of rapid deployment forces in the Middle East and elsewhere
- \* promoted the stealth jetfighter
- \* first came up with the concept of Star Wars: laser warfare from outer space
- \* openly advocated nuclear first strike capability
- \* proposed "protracted limited nuclear war" as a viable strategic option
- \* initiated military aid to El Salvador
- \* sent the first 'military advisors' to El Salvador
- \* sent Nicaraguan Dictator Somoza 79 million dollars in aid between Jan. '79 and his fall that July.
- \* In his current platform Mondale calls for a 3 to 5% increase in military spending each year (after inflation), continued aid to El Salvador, and deployment of the Cruise and Pershing 2 missiles.

## Corporate connections

"Fritz Mondale, he's very easy to get to. I talk to Fritz fairly often."

After he left his position as Vice President, Walter Mondale proceeded to become a millionaire. He accepted jobs with Control Data Corporation as a board member and with the Northwest Energy Corp. (NW Energy). Control Data Corp. (CDC) is known for its dealings with apartheid South Africa and NW energy with the building of the trans-Alaska pipeline.

When the Rev. Jesse Jackson attacked Mondale about his position as a board member of CDC, Mondale responded, "On several occasions I did express my concerns at board meetings about the company's dealings with South Africa." With regard to the NW Energy Corp., he could only say that he had assisted them while vice president.



GARY HART

In 1981 Gary Hart sponsored legislation to limit asbestos miners' rights to seek compensation for asbestos related illness. Under the bill the corporations would not be liable after the workers had quit work for three years. Asbestos fibers cause cancer and "white lung", both of which may take up to twenty years for symptoms to appear.

His actions undoubtedly relate to his association with the asbestos mining firm Johns Mansville Corp., which contributed generously to Hart's 1980 reelection campaign. The corporation was near to bankruptcy as workers filed to collect damages from years of work in air laden with heavy concentrations of asbestos fibers. In short, Hart's plan was to bail out the corporation at the expense of the workers.

A sad note is Hart's vote against legislation to remove building materials impregnated with asbestos fibers from public school buildings.

Gary Hart is deeply embedded in the escalation of militarization, he would "follow the mainstream foreign policy that American presidents have followed since WW II." This includes:

- \* 3% growth in military spending after inflation
- \* support of the deployment of Cruise and Pershing 2 missiles around the world
- \* continued aid to El Salvador
- \* a focus of war monies on "cost effective weaponry"

As an enemy of the environment Hart has:

- \* voted Senate confirmation of James Watt
- \* favored Reagan's 41% increase on Research and Development money for nuclear power
- \* supported a radioactive nuclear waste disposal bill that would have denied state's rights to judicial review or public comment, allowed decisions to be made without Environmental Impact Statements, and removed all responsibility for radioactive nuclear waste accidents from industries.



JESSE JACKSON

Jesse Jackson will remain an enigma to those of us protesting our lack of democracy and the corporate control of electoral politics. He is a political opportunist of the first magnitude, fully committed to capitalism and the "be somebody" rhetoric that pits black against black and white in the struggle to the top of the heap. On the other hand, he is clearly outside the democratic mainstream where the doors are closed to the needs of the black community. Our goal in this handbook is to expose the connections between the Democrats and the corporate machine that controls our domestic and foreign policy. Jesse certainly is no exception to this rule.

"I was born to lead" -- Jesse Jackson

- \* PUSH, Jackson's community group has been primarily concerned with expanding financial opportunities for black businesses.
- \* PUSH has received generous corporate contributions from Coors Brewery, a firm renowned for its anti-union and racist policies.
- \* PUSH promoted a strike-breaking during a Chicago teachers strike last fall. They petitioned a federal judge to order the school board to provide classes, if necessary with scab teachers.
- \* Jackson has proposed that the level of military spending be increased to allow for inflation, keeping the same huge military budget, and that we pressure U.S. allies such as Japan and West Germany to greatly increase their arms budgets.
- \* Jackson has been firmly entrenched in the Democratic Party, joining the Carter campaign at the end of the '80 elections for a final sweep through the urban areas. For this PUSH received \$4.9 million during Carter's presidency. Since 1968 Jackson has endorsed every Democratic Presidential nominee.
- \* Jackson's annual salary from PUSH is \$52,000, with another \$10,000 to \$30,000 a year being received in speaking fees. And a Chicago car dealer provides him with a chauffeur-driven limousine.



## DIANNE FEINSTEIN

Dianne Feinstein has consistently sided with the forces for downtown SF development against tenants, minorities and the gay community. As mayor of SF she:

- \* has destroyed many landmarks and low income housing projects in the downtown, including:
  - the I-Hotel, home of many elderly Filipinos
  - the City of Paris Building, an historic landmark renowned for its architectural beauty
  - the Goodman building, a center for artists
- \* appointed a Planning Commission that has not rejected a single downtown highrise proposal in four years.
- \* currently is pushing for even more unrestrained development in the form of the Southern Pacific Mission Bay blockbuster and the downtown coliseum.
- \* has vetoed legislation to stop the upward spiral of rental prices:
  - rent controls on vacant apartments
  - regulations that would have given the Rent Board authority to take legal action against landlords who violate the law.
- \* betrayed the gay community by vetoing the domestic partners ordinance.
- \* refused to use funds from a \$150 million budget surplus to alleviate the plight of SF homeless and poor.
- \* spent \$9 million in city money for convention '84 including 4.5 million on the city police force

In her battle to remove the poor and homeless from SF and to make our city the Manhattan of the West, she has received support (not surprisingly) from numerous big businesses and corporations.

- \$14,500 from Shaklee Corp.
- \$10,000 from Foremost-McKesson, Inc.; Standard Oil of California; Bechtel; Pac Tel; BankAmerica Corp.; Southern Pacific Co.; P,G & E and Transamerica Corp.
- Smaller amounts were received from numerous developers, including Olympia and York, Pier 39 Shopping Center, Gerson Bakar and the Rockefeller development interests.



## WILLIE BROWN

Willie Brown, the Speaker of the California Assembly, and the most powerful person in the state besides the Governor, has often used his power to benefit developers, even those from which he has received pay.

- \* In both 1982 and 1983 he received more than 10,000 dollars from Southern Pacific Corp. to work on the Mission Bay development Project in SF.
- \* He has sponsored two bills to facilitate the sale of land to Southern Pacific.
- \* By Southern Pacific's own admission, this will save them from two to ten million dollars.

He has received more than \$10,000 from seven development corporations in the last year for legal work. They are Southern Pacific, Olympia and York, Gerald Hines, Pan Med Enterprises, Tri-County Development, Ron Cowan, and Traweek Corp.

He has received gifts from the California Council for Environmental and Economic Balance, a group of big business interests.

He allowed his name to appear on a poster opposing Prop. M in the Black communities of SF. Prop. M would have required downtown SF businesses to help pay the costs and impacts of development, rather than having the whole burden on the poor and working class people of SF.

## WALTER SHORENSTEIN OWNER AND CHAIR, MILTON MEYER 1 CALIFORNIA


No other person is as responsible for the congestion and chaos of downtown San Francisco as Walter Shorenstein. His firm is one of the largest when it comes to owning and managing commercial property. Nationally, Shorenstein companies own or manage 12 million square feet of office space, worth 2\$ billion. In SF, Shorenstein owns many of the downtown highrises, including 333 Market and 1 California, and his firm manages the Transamerica Building.

Shorenstein has fought every effort to restrict highrise construction. In his view, zoning laws only interfere with the free market. "San Francisco is a self-regulating city for office buildings. If there is too much supply, developers will stop building until the supply is absorbed."

Shorenstein has cemented his financial power by being an active participant in Democratic party politics at every level. He gave \$10,000 to sympathetic supervisors during the last election. On the state level, Shorenstein gave Willie Brown \$5500 in 1982, which Brown could then distribute to his cronies in the Assembly.

Shorenstein is the chief fund-raiser for the Democratic Host Committee. He is busy soliciting large contributions from the country's biggest corporations. In return they get access to the convention floor and a party with the nominees. Says Shorenstein, "If you are a \$100,000 donor and you want something, you'll get it."

- \* leading fundraiser for 1964 Republican convention in SF, responsible for the nomination of Goldwater
- \* once estimated that he owned or managed 1/4 of the non-institutional office space in SF
- \* "If you make contributions, we in turn are going to treat you right. If not, don't ask for the same privileges as the people paying for it."




## DUANE GARRETT SENIOR PARTNER, HANSON, BRIDGETT, MARCUS, VLAHOS, STROMBERG 333 MARKET

Garrett is national co-chair of Mondale's campaign. He got this position because of his ability to extract contributions from the rich. In 1982 Garrett raised over \$2 million for Democratic candidates including Jerry Brown and Tom Bradley. Garrett is himself a major contributor. In 1982 he gave Roberti \$18,000, which Roberti in turn distributed to his friends in the state Senate. Garrett also gave Bradley \$65,000 in gifts and non-returnable loans during Bradley's 1982 campaign for governor. Garrett is a partner at Hanson, Bridgett.

Garrett is extremely ambitious. Only 36, he has already announced his intention of replacing Charles Manatt as head of the Democratic National Committee. Garrett is becoming one of the key links between the corporate world and the Democratic party.

- "The growth of Soviet military power makes us keenly aware of the need for the NATO alliance to modernize and improve its defenses."

# Corporations: Who pulls the strings?

## POLITICAL ACTION COMMITTEES (P.A.C.'s)

Since the writing of the Constitution, the U.S. government's main interest has been to protect the rights of property owners. From slave owners to oil companies, government has been primarily influenced by the rich. Due to public pressure there have been efforts, perhaps in vain, to legislate the amount of power businesses can wield. In 1925 the Corrupt Practices Act makes it "unlawful for any national bank or any corporation . . . to make a contribution or expenditure in connection with any election to any political office." The law, however, permits a non-corporate donor to give up to \$5000 to one political campaign committee. These laws were designed to provide the illusion that all is well and democratic while permitting numerous ways for corporations to contribute indirectly and turn economic power into political power.

Here are some examples and common practices:

1. Political Action Committees (PACs): Non-corporate entities through which corporations can donate to political campaigns (i.e., Socal/Chevron PAC, Transpac (Transamerica PAC), etc.)
2. Corporations loaning employees to work in political campaigns while still paying their salary.
3. Corporations paying professional fees to attorneys with the understanding that a portion of the fee is to be contributed by the attorney to a specified political candidate.
4. Corporations which rent billboard space on a yearly basis turn space over to candidates without charge preceding an election.
5. Arrangements by corporations to pay fake invoices that are supplied by a candidate's advertising agency.
6. Letting a candidate use company airplanes, hotel suites, credit cards.
7. During his 1968 bid for the Democratic presidential nomination Senator Eugene R. McCarthy was able to pay only parts of the substantial bills he ran up. Various McCarthy Committees owed AT&T \$305,000 for telephone service but payed only \$75,000. American Airlines was owed \$285,000, but payed only \$141,000. American Airlines correctly said that a corporation which settles a politician's bills for less than owed is in effect making an indirect campaign contribution.
8. Donating money to campaigns through individuals so the corporation identity becomes impossible to trace.


These are various ways for a corporation to by-pass the law. In the past PACs have been extremely popular. In a 1983 Business Week article it was said that, "after decades of feeling left on the wrong side of the Potomac, top executives of the nation's largest corporations say that their message finally is being heard in Washington and that they are getting their money's worth out of political campaign contributions." In a recent poll, 90% of all businessmen said that they think business is better able now to get its message across in Washington than it was five years ago. There is a direct correlation between this increase in influence and the incredible increase in money donated to PACs: More than \$80 million to 1982 House and Senate candidates, and an expected \$100 million during the '84 elections. One may think that the conservative nature of business would lead corporations to donate more heavily to Republican candidates, but as we see from the poll the money is divided evenly. No candidate is beyond the influence of money. As described so well in a Common Cause brochure "There's always been some corruption in American politics. What has happened with political action committees is we've institutionalized that corruption . . ."

Besides their involvement in political campaigns, corporations spend a vast amount of money lobbying in Washington. An estimated 15,000 business lobbyists operate in D.C. and spend some \$2 billion annually. These numbers contrast with some 50 public interest lobbyists spending some \$3 million a year.

The ties are unmistakable and gross in their enormity. Yet the Democrats continually try to fool the public by pretending to be the party of the working people. The Democrats equal the Republicans in their personal connections to and financial support by the corporations. The US's 2 party system is appropriately described by Ferdinand Lundberg, author of The Rich and the Super-Rich (1968).

The U.S. can be looked upon as having, in effect, a single party: the Property Party. This party can be looked upon as having two subdivisions: The Republican Party, hostile to accommodating adjustments (hence dubbed "Conservative") and the Democratic Party, of recent decades favoring such adjustments (hence dubbed "Liberal").

The electoral process is an extremely expensive and elaborate procedure. Simply stated elections cost money and lots of it, and it is quite obvious who has the money to give (or should we say invest). Not you, not I, rather the large corporations, business groups, and centralized organizations such as unions, etc., have all the bucks. In this context, how are the concerns of those most in need to be met? The homeless, the poor, the unemployed, are all effectively excluded from the process.

Sure, we get fined, I mean, hell, I'm sure you haven't gone through life without a traffic fine or something . . . I'm sure that during the course of time that we have been sitting here that we have probably had three or more charges filed against us."

**SOUTHERN PACIFIC  
1 MARKET**

Southern Pacific was the first of the California robber baron railroads. It launched the fortunes of the Stanfords, Huntingtons and Crockers. Now its railroad interests are secondary to its land holdings. The SP is the largest landholder in San Francisco. It intends to transform a 100 acre industrial site in the China Basin into a \$4 billion maze of high-rises and luxury condos. This will greatly add to downtown congestion, as it will cause more noise and pollution and overload public transit.

The SP plan has sparked intense opposition. To smooth the way, the SP has been lining up influential Democrats. It gave Willie Brown more than \$10,000 in both 1982 and 1983 for "legal services." In 1982 the SP gave David Roberti, Democratic State Senate leader, \$1800. Last year the SP gave Mayor Feinstein \$10,000 during the recall election. State election financing laws do not cover recall elections, so the recall was a bonanza for Feinstein, as well as a golden opportunity for the SP to funnel money to the pro-development mayor of the City.

**Donated:**

- \$100,000 for the Democratic Host Committee
- \$50,000 for the "Oh What a Night" party given by State Assembly Speaker Willie Brown.
- \$8700 for Bradley's 1982 campaign for governor.
- \$10,000 for Feinstein's 1983 recall election campaign.

- \* B of A is a top-five shareholder in a number of gigantic corporations like Westinghouse and Union Carbide.
- \* Had over \$200 million loaned to the communist dictators of Poland in 1981, the time of some of the heaviest repression against the independent trade union Solidarity.
- \* Leland Prussia, chairman of the board, sits on the Host and Business Council Committees for the '84 DNC. "Anyone who operates in this area--and, of course, we do--will profit from this convention."



**DIAMOND SHAMROCK  
601 CALIFORNIA**

Diamond Shamrock is a major contributor to the Democratic Party. It provided the Host Committee with \$100,000 for the Democratic convention.

A huge energy corporation, with oil and gas interests from exploration to marketing, Diamond Shamrock is also a major producer of chemicals. It was in this role that DS became one of the largest suppliers of Agent Orange to the government for use in Vietnam. Over 12 million gallons of Agent Orange were sprayed over Vietnam in order to destroy and defoliate its countryside.

Agent Orange contains dioxin, one of the deadliest chemicals yet discovered. Thousands of U.S. soldiers were exposed to Agent Orange, and thus dioxin, while in Vietnam. Years later they are suffering the effects in cancer, skin disease and liver disorders. Recently Diamond Shamrock, along with the other Agent Orange producers, finally agreed to establish a \$180 million fund to compensate the Vietnam veterans. Yet this does not begin to counterbalance the tremendous misery caused by the use of Agent Orange. Soil samples near a Newark, N.J., plant recently closed by Diamond Shamrock after years of producing Agent Orange contained high concentrations of dioxin. Above all it is the Vietnamese people who should be compensated by Diamond Shamrock, and by the U.S. government, for the use of a deadly chemical weapon.

**PACIFIC BELL  
444 BUSH**

Pacific Bell was awarded the lucrative contract for handling all telecommunications for the DNC '84. Perhaps it was in recognition of the \$50,000 contribution PacBell made to offset the Democratic Party's expenses for the convention. PacBell received more than \$8 million in Pentagon contracts in 1983.

**CONTROL DATA  
1 MARITIME PLAZA, S.F.**

After his 1980 defeat, Mondale joined the board of directors of Control Data. He received \$145,000 over the next two years for his efforts. Mondale is a long-time friend of William C. Norris, CDC chair, and Norris was a frequent visitor to the Carter-Mondale White House.

In 1981 Mondale went on a trip to the Far East. One stop was South Korea where he visited a CDC plant in Seoul and then spoke with Korean government officials on behalf of CDC.

**Foreign**

- \* one of the largest computer manufacturing companies . . . has computer service center in Tokyo for science and engineering services, particularly in the nuclear industry.
- \* 1978: pleaded guilty to charges of paying \$200,000 in bribes between 1967 and 1973 to officials of an undisclosed foreign country, penalized \$1.4 million.
- \* 1978: decided to stay in South Africa despite increasing political pressure. "The South African branch is the most profitable in the group outside of America. South Africa is a growing market. There are greater opportunities here than anywhere else."
- \* 1982: About 100 Korean workers--almost all young women--held two officials of CDC for more than nine hours when negotiations over the reinstatement of six women union officials reached an impasse.
- \* 1983: Israel sends arms to Honduras
  - CDC owns 37% of Elbit Computers (Israeli based) which manufactures electronic warfare equipment.
- \* pursues business opportunities in the Caribbean Basin and Central America.
- \* uses 15-30 cent hourly wage in Taiwan and Hong Kong (is in 50 countries).
- \* in Tijuana, employees 200 people at \$3.68 a day.
- \* owns 10% of the computer business in South Africa.

**Domestic**

- \* provides equipment and services to NASA, GM, Boeing, Dow Chemical, Lockheed, Martin Marietta (all defense contractors)
- \* prime contractor for the Vietnam War
  - provides computer services for missiles, aircrafts, etc., automated or electronic warfare to detect elusive enemy (guerrilla warfare).



**PILLSBURY, MADISON, SUTRO  
225 BUSH**

The oldest, largest and most powerful law firm in San Francisco. In 1983 it had 307 lawyers, including 138 partners. Of the partners, none were Black or Hispanic and only 8 were women.

Pillsbury, Madison wrote up the papers which incorporated Standard Oil of California, and it is still that firm's general counsel. The law firm is housed in SoCal's headquarters in order to facilitate closer relations. According to Pillsbury's managing partner, "We're very close to Standard and they'd like to keep us readily available.

Pillsbury, Madison also works for DuPont, the producer of chemical warfare products used in Vietnam and around the world today, and Utah International, one of the country's most notorious land rapists.

## TACTICS

### INTRO

Although our freedom of movement is protected by the constitution, the streets (like the rest of our lives) are closely patrolled by the authorities. We can reclaim this space. Today, the streets offer us the hope of building community, and of countering our isolation and dehumanization. If we can not freely gather, meet each other, express ourselves and demonstrate our feelings then how can we build community and hope to control our lives and future? Let's reclaim the streets and replace the commercialism and death dealing with community, creativity and life.


**Die-ins** By far the most popular way to disrupt the normal flow of business through the financial district. At least 5 people start counting down from 10 to 1 as they slowly move into an intersection. At "ground zero" everyone screams and collapses in the street as if nuked. Some people remain standing to make sure no one gets run over. Before the police can get there, the dead arise and move onto another strategic intersection.

**Human Blockades** Involve a willingness to be arrested. The idea is to use your body to obstruct the business of the offensive corporation. People chain themselves to the main entrance or lie in the doorway.

**Occupations** Occupation of missile test sites have prevented the tests themselves. Occupations of war corporations have shut them down for days. Worker's occupations of factories have prevented cold lock-outs during strikes and even provided a basis for what they call "auto-gestion" in Europe--self managed factories that are "on strike" yet keep producing without taking orders from the bosses.

**Consensus & Collective Process** Too often so-called social change groups reproduce the hierarchy and hypocrisy of the establishment within their own working structures. Any revolution will be built on completely new social relationships. Begin this process in your own group -- end the tyranny of the majority rules (because we are all minorities). Consensus means everyone in the group agrees with the actions the group takes, or they can "block" a decision that violates their fundamental principles. The unity of purpose that rises from groups that use consensus is impossible to defeat.

**Affinity Groups** Small, trusting groups of people work better in the streets than masses of isolated demonstrators. If a small group wants to evade cops, they break down into smaller groups and reunite at an agreed-upon place. This confuses infiltrators and police that may be monitoring the activities.



**Spray-painting** This artistic vandalism really spoils an businessman's day and also the unity of his bourgeois aesthetic. It replaces the dead greyness with creativity and life.

**Work Stoppages/Slowdowns** Pull the plug out on your Xerox machine, crash the office computer system, drop that important letter in the wrong box. All of these actions help to undermine the system and bring us one step closer to freedom.

**Direct Communication** Talk to and leaflet financial district workers and conventioneers and encourage them to question their activities and redirect their efforts.

(During the DNC '84 ongoing workshops will be held on street tactics throughout the financial district.)

**Destruction of Property** Recently an MX missile production facility was shut down when someone rolled a truck into the main transformer. Phonelines in LA were cut by saboteurs several weeks ago. While these are powerful actions, too many people romanticize sabotage without examining the actual impact and effect of their actions.

**Weaving/Snake dancing** Used in Japan successfully at demonstrations, it keeps the police from isolating individuals. Witches at Livermore linked arms and "weaved" throughout the road, slowing traffic for hours.

**Theater** Many groups have performed for audiences at demonstrations and had impact. But the separation between performers and observer has never been completely broken down, leaving people out of the action. Street theater can be done anywhere, on-the-spot, without rehearsal -- it's a dramatic form of communication.

**Blockades with Physical Objects** Study the terrain of the city--what can be readily converted into a street obstacle?

### THE SAN FRANCISCO POLICE DEPARTMENT

\* Have spent over \$4.5 million on security measures for DNC '84, including \$169,000 on communications. They will not lack anything for maintaining what they euphemistically call "public order;" they have everything from hundreds of disposable plastic handcuffs to two cases of flash-and-stun grenades. They have announced that they will have enough room to house 1000 protesters for the duration of the festivities. We have learned that this site will probably be Potrero High School, but this has not been announced by the police. (Police frequently hold large groups of arrestees in schools--coincidence?)

\* 200 sheriff's deputies will work 12-hour shifts to back up 1000 police officers in the streets of San Francisco. Police administration officials admit that lack of experience is widespread among rank-and-file police: most beat cops have less than three years of experience on the street. Senior police officers have noticed a particular group of younger officers, those in the 24-28 age group, developing what they term a "do-your-own-thing mentality" and readiness to use force in conflict situations.



\* State delegations will be travelling by bus from their hotels to the Moscone Center. Each bus will be accompanied by an escort of police and sheriff's deputies "riding shotgun" in case any protesters attempt to block passage to the Moscone media circus.

\* Undisclosed numbers of plainclothes police will circulate throughout all the demonstrations to "keep an eye out for troublemakers." "Speedy arrest units" will be ready to isolate and process and instantaneously jail anyone who won't follow orders. In the past in San Francisco people who have pointed out and exposed undercover cops in our midst at demonstrations have been arrested. If you are certain that someone is an undercover cop you can expose them and avoid arrest by getting a group of people (about 7 or more) to simultaneously chant "undercover cop" while pointing him/her out to everyone else.

\* However, experienced street artists, disrupters and blockaders say that all this hairy information the police have given to the press is meant to intimidate people from exercising their right to free speech and attending the many actions and demonstrations planned for the convention. Indeed, they scoff at the suggestion that the SFPD will control the situation on the streets of San Francisco, and say they will not even effectively direct traffic during DNC '84.

\* The SFPD is still reeling from the staggering blow to its credibility that came with the "Rookie Cop Sex Party" scandal, when the graduating class of the Police Academy and a large number of senior cops were treated to the spectacle of a prostitute hired to rape one of the shiest recruits onstage at a party at the Rathskeller.


